Please find listed below the process for applying for need-based financial aid if you plan to take a Summer Session 2024 course at Babson and need financing options.

<u>Financial aid applicants should complete page 2 of this form and submit it to SFS by April 1, 2024</u>. Save a copy of page 2 with your name included in the file and email a copy to <u>sfs@babson.edu</u>. If you have any questions related to financing options or submitting the form, you can email your SFS counselor for assistance or reach out to SFS at <u>sfs@babson.edu</u>. Please note the following:

- Financial aid applicants must complete their 2024-2025 financial aid application by **April 1, 2024**. Your 2024-2025 financial aid package, including summer, will be available by April 22, 2024. You can confirm the status of your 2024-2025 file using the Babson Hub.
- Payment for summer, including any financial aid, is due on Wednesday, **May 1, 2024**. Your summer registration will be at risk of cancellation prior to the start of classes if payment is not received on a timely basis.
- Funding is limited; students who plan to take 6 or more credits during the summer will typically have more financial aid options
 available to them as many programs require half-time attendance (6 or more credits). We are unable to provide institutional
 funding for repeated or substituted courses due to a failure or withdrawal from a course.
 - > Students who receive <u>full-tuition</u> scholarships (*Posse*, *Diversity Leadership*, *Weissman*, *Global Scholars*, *Enrico*, *Baldwin Richardson*, *NFTE*, *AMBSEL*): Your award covers full-tuition up to 8 semesters, plus two courses.
 - Federal Direct Loan: If you will be enrolled in 6 or more credits during the summer and are a U.S. citizen / Permanent Resident, you can borrow through the Federal Direct Loan program.
 - > <u>Supplemental Loans:</u> If you have borrowed supplemental loans in prior semesters, that may be an option for summer as well. You can find additional loan information on our website at www.elmselect.com.
